1. Permission is for **one-time use only** with no other rights. Any subsequent use (including, but not limited to, subsequent editions, paperback editions, foreign language editions, etc.) constitutes re-use and must be applied for in writing to ONE Archives. An additional fee may be charged for re-use.
2. Permission for publication or commercial use limited to individuals/agents who have obtained reproductions directly from ONE Archives. Permissions and reproductions may not be transferred to a third party.
3. **All reproductions must be credited "Courtesy of the ONE National Gay & Lesbian Archives."**
 - a. Credits to the "ONE National Gay & Lesbian Archives" should appear in close proximity to the image or in a special section devoted to credits. **Reproductions distributed electronically must contain the credit or caption as part of the image.** When known, the photographer should be credited as well. Crediting of each individual item is mandatory in all cases.
 - b. With films, filmstrips, slide presentations and video productions, credit must appear either with the image or with other credits at the beginning or end of the production.
 - c. With display or exhibition, please credit within the display or exhibition area. Exemption from this requirement must be approved by the ONE Archives.
4. **Website restrictions:** Images used on a website should not be more than 72 ppi. The long side of the image should not be more than 550 pixels. Compressed jpeg files should not be larger than 50 kb.
5. Applicable fees will be assessed for reproductions used for publication or commercial use as described on the fee schedule. Payment of fees does not exempt the user from the credit line requirement or any conditions herein unless otherwise stated. Please see the **Reproduction and Use Fees** form or contact archives staff for fee schedule.
6. Accompanying captions must indicate all changes made to the original copy, such as manipulation, significant cropping, tinting, superimposing, etc.

7. One complimentary copy of each publication in which any reproduction appears must be sent to the ONE Archives.
8. The user may not reproduce or permit others to reproduce (by any means) the reproduction or any facsimile of it. Additional copies must be purchased from the ONE Archives.
9. The user may not reproduce the reproduction in an advertisement or any commercial use of a similar nature, nor mass produce as unbound material, unless permission has been applied for and approved by the ONE Archives.
10. In authorizing the publication of a reproduction, ONE Archives does not surrender its own right to publish it, or to grant permission to others to do so.
